### **Local Jamaica Plain Artists on Display at BCEC**

The Massachusetts Convention Center Authority today announced the final selections from Boston's Jamaica Plain Open Studio Artists to display their artwork at the Boston Convention & Exhibition Center for the next several months. The show, consisting of two dozen original artworks, will be on display until the end of April on Level Two at the BCEC's Northwest lounge area. It is part of the growing effort to bring the work of Boston artists to the public eye.

Sue Merritt, Art Consultant for the MCCA, received entries from 38 Jamaica Plain Open Studio Artists: 150 total original works were submitted for consideration. To date, this is the highest total number of entries from any of Boston's neighborhoods. Twenty-four pieces were chosen for display, ranging from paintings to photography and mixed media compositions.

"Jamaica Plain is a neighborhood of Boston that is very ethnically diverse; a modern day melting pot," said Merritt. "There is a shared sense of pride and community spirit for all levels of creativity, including professionals, amateurs and hobbyists."
